Essex RoSPA Advanced Motorcyclists (ERAM)

The Data Protection Act (the Act)

- 1) ERAM holds its membership records on a computer database and in other formats
- 2) In accordance with the Act, it is necessary to ask you to agree to your details on the membership application form being processed using computers and other means.
- 3) If you do NOT agree, we may not be able to process your application for membership
- 4) If you do agree, it is necessary that you are made aware of the circumstances in which the information is used and when it might be disclosed.

The Details

- 5) The ERAM Membership Secretary will enter your details into a computer system. Your details are primarily used to produce mailing labels for the Group's newsletter, maintain an email distribution list and to facilitate the administration of ERAM.
- 6) The membership database stored on computer is password protected for security purposes.
- 7) Any active committee member who has a legitimate need may request a copy of the membership list.
- 8) RoSPA HQ may request a copy of the membership list.
- 9) All new member names are automatically sent to the Newsletter Editor for publication in the newsletter.
- 10) Member information (Full or Associate) will be shared with the Training Officer if that member requires training, or that member becomes a Tutor within ERAM.
- 11) Individual member information (Full or Associate) is also sent to the allocated Tutor if that member requires training, in order that initial contact can be made.
- 12) When you pass your RoSPA Advanced motorcycle test, please inform the Membership Secretary to update you to Full member for the rest of your ERAM membership period.
- 13) To maintain your ERAM Full membership you must also maintain membership with RoADA.
- 14) In the event of a computer breakdown it may prove necessary to disclose the data to a maintenance company in order to repair the computer or computer programme.

- 15) Another ERAM member may request your details in order to make contact with you. In order to save time and cost, we will not seek your consent every time.
